

### **SAFE ROUTES TO TRANSIT**

Overview of current pedestrian conditions near the stop


This program, presently in planning, improves pedestrian conditions near high ridership bus stops. At this location, we will be looking into:

- Adding sidewalk and ADA ramps to connect the new shelter to the intersection
- Mark the crosswalks to increase visibility or crossing locations by vehicles
- Reduce the crossing distance and vehicle turning speed at corners to provide a safer crossing environment.



### **SAFE ROUTES TO TRANSIT**

- The SR2T program is funded for 2 cycles across our service area.
- 2024: Clayton County and MARTA selected and designed 16 sites for Cycle I
- November 2024: Clayton and MARTA kicked-off the 2<sup>nd</sup> cycle of the program selecting and designing sites.
- 2025: MARTA will initiate the procurement process to select designbuild vendor.







- A Clayton County constituent requested the removal of a MARTA bus stop to Commissioner Reaves.



### MARTA RAPID SOUTHLAKE (BRT) UPDATE

- Securing final design consultant to bring project to 100% design
- Categorical Exclusion secured
  Responding to DCE common
  - Responding to DCE comments
  - Environmental full completion by November 2025.
- Awaiting federal funding rating
- ✓ TOD Study awarded to VHB

Investment: \$356M Projected revenue service: 2030






## MARTA RAPID SR-54 (BRT) UPDATE

- Refinement of project schedule, with target for approved LPA in 2025
- Tiered alternatives analysis to address early concerns and local coordination needs
  - Tier 1 Completed in February 2024
  - Tier 2 Completed in October 2024
- Planning charette scheduled:
  - March 11th (Morning: 9 AM 12 PM) Clayton State University – Harris S. Downs Center
  - March 13th (Afternoon: 12 PM 3 PM) Jonesboro City Center

Investment: \$582M Projected revenue service: 2030





### **MULTI-PURPOSE OPERATIONS & MAINTENANCE FACILITY**

Site demolition began in Jan. 2025
 9-month duration

- ✓ 100% design plans expected to be ready for bid Q3 2025
- Estimated start for construction build back is August 2026

Investment: 289M Full completion target: August 2029

## JUSTICE CENTER TRANSIT HUB

- 100% design and cost estimate delivered by April 2025
- ✓ Invitation for Bid targeted for Q2 2025
- Secondary security fencing between the transit hub and the Justice Center will be installed by Clayton County and completed by Q2 2025

Investment: \$22M Full completion target: December 2027
